# FREQUENTLY ASKED QUESTIONS

## How much are fees?

Using ColoradoGives.org is one of the most cost-effective ways for nonprofits to fundraise online. Third-party vendors charge credit card and electronic check processing fees when donors make online donations. Two percent of each donation helps cover these fees. Unlike some other sites, we do not charge setup or maintenance fees. During the donation process, donors can elect to cover the fee so the nonprofit receives the full donation.

## Who can join ColoradoGives.org?

Every nonprofit wishing to join the site is screened to meet the following criteria:

- 501(c)(3) tax-exempt nonprofit organization
- Headquartered or providing services with a physical office in Colorado
- Reporting at least one entire previous year of financials with \$50,000 in annual revenue or \$25,000 in net assets as shown on most recent 990, 990EZ, third-party audit, third-party review or third-party compilation
- Registered with the Secretary of state with a valid Certificate of Registration and a valid Certificate of Good Standing

## What types of nonprofits are ineligible?

- Private foundations—filing a 990PF
- Supporting organizations—charity status of 509(a)(3)
- Public safety organizations—charity status of 509(a)(4)

## How can nonprofits join?

After reading the eligibility requirements, visit ColoradoGives.org. Click “Enroll” in the top grey bar. You will be guided to an online enrollment form. Please note that enrollment is open every year between March 1 and August 30.

## Who operates ColoradoGives.org?

Community First Foundation, a community foundation based in Arvada, Colorado, created ColoradoGives.org and Colorado Gives Day to increase online philanthropy in the state. Since 1975 the Foundation has been helping generous donors and innovative nonprofits come together to improve quality of life in Jefferson County, the Denver metropolitan area and beyond.
